In the absence of processing fee the Compliance Report will not be entertained. Following the Compliance report, the Council would verify the status in respect of rectification of deficiencies through surprise random inspection without any prior notice.

- 4 That the tuition and other fees shall be charged as prescribed by the Competent Authority within the overall criteria prescribed by the Council from time to time. No capitation fee shall be charged from the students/ guardians of students in any form.
- That the accounts of the Institution shall be audited annually by a certified Chartered Accountant and 5 shall be open for inspection by the Council or any body or persons authorized by it. 5
- That the Director/ Principal and the teaching and other staff shall be selected according to precedures, qualifications and experience prescribed by the Council from time to time and pay scales are as per the 7
- That the institution shall furnish requisite returns and reports as desired by AICTE in order to ensure proper maintenance of administrative and academic standards.
 - That the technical institution shall publish an information booklet before commencement or the (b) academic year giving details regarding the institution and courses/ programmes being conducted and details of infrastructural facilities including faculty etc. in the form of mandatory disclosure. The information booklet may be made available to the stakeholders of the technical education on cost basis. The mandatory disclosure information shall be put on the Institution Website. The information shall be revised every year with updated information about all aspects of the institution.
