Development has been a focus of humankind since ancient times. It involves creating social conditions that sustainably and equitably foster individual and collective well-being. However, the path to development has undergone various debates and changes across different periods, involving shifts in concepts, theories, and practical approaches. The idea of social development emerged when it was felt that true development could not be achieved solely through economic advancement. Its proponents advocated a holistic and multi-level approach, instead. Social development is a broad concept that involves significant changes in politics, economics, and culture, all aimed at transforming society through deliberate efforts, characterised by increased capacity within the social system, social structure, institutions, services, and policies to effectively utilise resources and generate positive changes in the standard of living.

The world is constantly facing challenges in ensuring peace and stability that enable people to live in harmony. War, conflict, poverty, political instability, human rights violations, forced displacement, climate change etc. call for a united effort if we are to advance the UN's sustainable development goals. Social workers and social development professionals play a vital role in addressing the many challenges faced by individuals, communities, and societies. It is essential to view 'development' as a process as well as an outcome, realizing that achieving such an aim requires engagement with multiple stakeholders to find inclusive pathways, especially for the most marginalized and vulnerable communities. As a concept in social work, social work practices at the micro, meso, and macro levels have a considerable role in social development. As the world moves swiftly towards the postmodern era, innovations in areas such as new approaches to service delivery, technology integration, policy changes and community organising strategies, are necessary to achieve the desired end.

The ICSD 24th Biennial International Conference aims to provide an opportunity to critically reflect on the multiple ways in which social work and social development professionals have advanced innovative solutions to unite and improve outcomes for individuals, families and communities, locally and globally. The conference will also celebrate ICSD's golden jubilee; and silver jubilee of DYUTI showcasing its commendable contribution to the field of social work and social development across the world.

- Restorative justice programs and conflict resolution models.
- Alternatives to incarceration and community-based rehabilitation.
- Addressing systemic inequalities within justice systems.
- Peace-building strategies

6. Education and Lifelong Learning:

- Innovative educational approaches and inclusive schooling.
- Lifelong learning opportunities for marginalized communities.
- Technology-enhanced learning and distance education initiatives.

7. Environmental Sustainability and Resilience:

- · Community-based environmental conservation projects.
- · Climate resilience and disaster risk reduction strategies.
- Promoting sustainable livelihoods and resource management.

8. Financial Inclusion and Economic Empowerment:

- Microfinance, microenterprise development, and savings-led initiatives.
- Social impact investing and alternative financing models.

9. Cross-Cultural Exchange and Global Collaboration:

- International partnerships and knowledge-sharing networks.
- Cultural exchange programs and cross-cultural understanding initiatives.
- Learning from diverse social work and development practices worldwide.

10. Ethical Practice and Professional Development:

- Ethical considerations in social work and development work.
- Supporting well-being, continuing education and professional development opportunities.
- Social work in times of crises (pandemic, war, forced displacement etc.)

Call for papers

We are calling for papers (for **oral and poster presentations**) that bring together novel solutions to development issues through social work and social development practices. All kinds of innovations will be considered, whether methodological, theoretical, social, technological, policy, practice-based or organisational and are of local relevance and/or have the potential for large-scale replication. Lessons learned from implementing evidence-based solutions, interdisciplinary approaches, and critiques of current solutions are also welcome. Interested participants can submit proposals for a **workshop** (90 minutes) or a **panel discussion** (4 panellists maximum on a theme excluding the chair,10 minutes each) on the related topics.
