OBJECTIVES

The objectives of Rajagiri Swachh (Clean) Campus Committee are:

- i)To build consensus on the need for maintaining a Clean and Green Campus among campus leaders at student level, faculty level and campus level.
- ii) Monitor the existing environmental performance of the campus in a participatory and transparent way.
- iii) Facilitate design of specific interventions for making the campus clean and green by following international standards and accepted parameters.
- iv) To Institute a Rajagiri Swachh Policy which will contain the following documents:
 - a. Water conservation policy: Optimum use of water, reuse of treated water, water saving appliances and water recycling.
 - b. Waste Management Policy: The "5 R" principles of reduce, reuse, recycle, refuse and regenerate as well as to reducing waste sent to landfill to less than 10% of waste generated. Banning all plastic disposable items from the campus is the first step. Drawing lessons from the Swachh campaign for handling computer and electronic equipment and other e-wastes. It should also contain sanitation and hygiene monitoring process.
 - c. Energy conservation and usage policy: Introduction of solar energy and reduction in energy consumption through technologies and management processes.
 - d. Rajagiri Green Protocol: A greening policy which looks into environmental sustainability and growing endemic and endangered species of trees covering at least 33% of land area on campus.
 - e. Ban on Plastic Policy: Reduce the usage of plastic, especially the single use plastic.
- v) To find ways and means of Partnering with other Institutions and Agencies such as:
 - a. Funding Agencies: State and central regulatory and finance agencies and ministries like HRD, water resources, sanitation, forests and environment as well as AICTE.

b.Donors: Alumni, NGOs, private foundations and corporate houses

c. Non-profit Organizations



d. Public Policy Groups and Think Tanks: Green Building Council, Centre for Science and Environment (CSE) and Council on Energy Environment and Water (CEEW).

e.Media

f. Government schemes

vi) To identify how Environment and Sustainability could be integrated into the curriculum

vii) To facilitate Green Audit annually

AREAS OF INTERVENTION

The major areas of intervention of Rajagiri Swachh (Clean) Campus Committee are:

- Good sanitation and hygiene practices
- Waste Management
- Water conservation practices
- Campus greenery
- · Energy conservation

SUGGESTED SWACHH ACTIVITIES ON CAMPUS

- 1. **Survey on Waste:** Sources of waste generation, the quantum of waste generated from each source per day, per week and per month are noted. After segregation of waste its quantity is calculated.
- 2. Plan and Prepare with the 5R principle: Preparation involves training everyone in scientific waste disposal, involving sanitation staff in planning and educating campus residents. Sanitation supervisor and staff are consulted for manpower requirements and deployment.
- 3. Facility, Equipment and Logistics: This includes bins, collection carts, uniform, safety gear, gloves and rakes for handling different kinds of wastes are provided at different locations. There are waste management facilities in campus with incinerator and compost/waste bins. There is a facility for sanitation workers to wash and clean. Bins, carts, vehicles in their most appropriate sizes are required and are to be placed at different locations in the campus with colour coding for easy waste segregation.
- 4. Segregation of Waste for Secondary Segregation and Resource Recovery: Covered sheds are located away from each other to avoid mixing. Shredders, sieves and other mechanical devices are provided. Collected waste is checked for proper surfailing before treatment. Tertiary segregation recovers recyclables and reusable wastes.



- 5. **Ban on Plastic in Campus:** Important practices include total ban on single use plastic items like plastic bottles, disposable plates and toiletries in sachets. Recyclables like e-waste, glass and plastics are given to scrap collectors.
- 6. **Reduction in Paper Waste:** Reduction in paper use and sharing of notes and documents are to be promoted. Two-side printing on paper is to be promoted.
- 7. **Orientation Programmes:** Conduct orientation programmes and seminars for all students and employees on Swachhta etc.
- 8. Contribution to Swachh Campus Initiative: Ensure all students and employees, including the outsourced ones, are contributing to the Swachh Campus Initiative.
- 9. **Integration of Development Aspects:** Integrate swachhta and sustainable development aspects and perspectives into the existing curriculum or as Value added Courses

PLASTIC BAN POLICY AT RAJAGIRI

Rajagiri College of Social Sciences has identified that:

- a) The institution needs to undertake a systematic campaign to reduce the usage of plastic, especially the single use plastic.
- b) The use of single-use plastic items by the stakeholders is detrimental to the environment, public health, and welfare.
- c) The distribution of single-use plastic items requires utilization of natural resources and results in the generation of greenhouse gas emissions.
- d) Single-use plastic items contribute to environmental problems, including litter in the landscape, drains, rivers and streams, and the ocean.
- e) Single-use plastic items impose unseen costs on the stakeholders, local governments, the state, and environment, and constitute a public nuisance.

Rajagiri College of Social Sciences does therefore find and declare that it should restrict the use of single-use plastic items.

With the above identifications, Rajagiri College of Social Sciences shall:

- 1. Ban the use of single-use plastics in canteens, facility centres and hostels.
- 2. Conduct awareness sessions, training programmes and workshops on the harmful impacts of single use plastics.
- 3. Encourage students, faculty and administrators to avoid bringing non-bio-degradable plastic items to the institution.
- 4. Encourage students to sensitize their respective households about the harmful effects of plastics and make their households 'plastic free'.
- 5. Mandate all departments/offices to avoid the use of plastic water bottles, encourage use of alternative solutions like jute files, paper folders, cloth bags, paper bags etc. for programmes, instead of plastic bottles, bags, covers and other goods on the Hill Campus and Valley Campus.
